Frozen Spring Phosphorus samples must be turned in between **8 am – Noon on June 25, 2024** for all counties. The turn-in location depends on your county and is given below in the table. Call the appropriate phone number below if other arrangements must be made. **PLEASE NOTE:** If you are enrolled in Chlorophyll, you need to turn in your May and June samples at the same time you turn in your spring phosphorus samples.
